



BTA AIRPORTS FOOD AND BEVERAGE SERVICES JOINT STOCK COMPANY INFORMATION NOTICE ON THE PROTECTION AND PROCESSING OF PERSONAL DATA WITHIN THE SCOPE OF INTERNET ACCESS RECORDS

1. DATA CONTROLLER

Your personal data may be processed by BTA Airports Food and Beverage Services Joint Stock Company (the “**Company**”) in its capacity as data controller, in accordance with the Law on the Protection of Personal Data No. 6698 (“**Law**”), within the scope explained below.

2. PURPOSE OF PROCESSING YOUR PERSONAL DATA

Your collected personal data may be processed in accordance with the fundamental principles set forth in the Law and within the scope of the personal data processing conditions specified in Articles 5 and 6 of the Law, primarily for the purposes of fulfilling our obligations arising from Law No. 5651 as a collective use provider, enabling visitor access to the internet network, and creating and monitoring visitor records, including but not limited to:

- Planning and/or execution of activities to ensure the legal and technical security of our Company and relevant persons in business relations with our Company,
- Provision of internet usage and access to Wi-Fi services,
- Fulfillment of obligations regarding the recording of internet access and usage,
- Prevention of unauthorized internet access,

(collectively referred to as the “Purposes”).

3. PARTIES TO WHOM YOUR PERSONAL DATA IS TRANSFERRED AND PURPOSES OF TRANSFER

Your collected personal data may be transferred, in accordance with the personal data processing conditions specified in Articles 8 and 9 of the Law, for the realization of the Purposes, to our domestic and international business partners, our shareholders including Aéroports de Paris Group, our suppliers, legally authorized public institutions, and authorized private individuals.





4. METHOD AND LEGAL BASIS FOR COLLECTING YOUR PERSONAL DATA

Your personal data is collected electronically via our wireless internet connection when you interact with our Company.

Additionally, your personal data is collected based on the legal grounds of fulfilling legal obligations and legitimate interests as regulated under Articles 5 and 6 of the Law.

5. YOUR RIGHTS AS A PERSONAL DATA SUBJECT UNDER ARTICLE 11 OF THE LAW

As a personal data subject, you are entitled to the following rights under Article 11 of the Law:

- To learn whether your personal data is being processed,
- If your personal data has been processed, to request information regarding such processing,
- To learn the purpose of processing your personal data and whether it is being used in accordance with its purpose,
- To know the third parties to whom your personal data is transferred domestically or abroad,
- To request the correction of your personal data if it has been processed incompletely or inaccurately, and to request that the transaction carried out in this context be notified to third parties to whom your personal data has been transferred,
- To request the deletion or destruction of your personal data in the event that the reasons requiring its processing cease to exist, even though it has been processed in accordance with the provisions of the Law and other relevant legislation, and to request that the transaction carried out in this context be notified to third parties to whom your personal data has been transferred,
- To object to the emergence of a result against you through the exclusive analysis of processed data via automated systems,
- To request compensation for damages in case you suffer harm due to the unlawful processing of your personal data.

Depending on the nature of your request, your application will be finalized free of charge as soon as possible and no later than thirty days; however, if the process requires an additional cost, a fee may be charged based on the tariff determined by the Personal Data Protection Board.
