



## **BTA AIRPORTS FOOD AND BEVERAGE SERVICES JOINT STOCK COMPANY INFORMATION REGARDING THE DATA SUBJECT'S RIGHT TO APPLICATION**

### **I. DATA SUBJECT'S RIGHT TO APPLICATION**

#### **• Scope of the Right to Application**

Pursuant to Article 11 of the Law on the Protection of Personal Data No. 6698 ("LPPD"), as data subjects, you have the right to submit a request to us regarding the following matters:

- (1) To learn whether your personal data is being processed,
- (2) If your personal data has been processed, to request information regarding such processing,
- (3) To learn the purpose of processing your personal data and whether it is being used in accordance with its purpose,
- (4) To know the third parties to whom your personal data is transferred domestically or abroad,
- (5) To request the correction of your personal data if it has been processed incompletely or inaccurately, and to request that the transaction carried out in this context be notified to third parties to whom your personal data has been transferred,
- (6) To request the deletion, destruction, or anonymization of your personal data in the event that the reasons requiring its processing cease to exist, even though it has been processed in accordance with the provisions of the LPPD and other relevant legislation, and to request that the transaction carried out in this context be notified to third parties to whom your personal data has been transferred,
- (7) To object to the emergence of a result against you through the exclusive analysis of processed data via automated systems,
- (8) To request compensation for damages in case you suffer harm due to the unlawful processing of your personal data.

#### **• Cases Outside the Scope of the Right to Application**

Pursuant to Article 28 of the LPPD, the following cases fall outside the scope of the Law, and therefore data subjects cannot assert their rights regarding the matters listed below:



- (1) Processing of personal data for artistic, historical, literary, or scientific purposes or within the scope of freedom of expression, provided that it does not violate national defense, national security, public security, public order, economic security, privacy of private life, or personal rights, and does not constitute a crime.
- (2) Processing of personal data for research, planning, and statistical purposes by anonymizing them with official statistics.
- (3) Processing of personal data within the scope of preventive, protective, and intelligence activities carried out by public institutions and organizations authorized by law to ensure national defense, national security, public security, public order, or economic security.
- (4) Processing of personal data by judicial authorities or enforcement agencies in relation to investigation, prosecution, trial, or execution procedures.

Pursuant to Article 28/2 of the LPPD, except for the right to request compensation for damages, data subjects cannot assert their rights in the following cases:

- (1) If the processing of personal data is necessary for the prevention of crime or for criminal investigation.
- (2) If the personal data has been made public by the data subject themselves.
- (3) If the processing of personal data is necessary for the performance of supervisory or regulatory duties and disciplinary investigation or prosecution by public institutions and organizations or professional organizations with public institution status, based on the authority granted by law.
- (4) If the processing of personal data is necessary for the protection of the economic and financial interests of the State in relation to budget, tax, and financial matters.

## II. FINALIZATION OF APPLICATIONS

In accordance with Article 13 of the LPPD, if data subjects submit their requests regarding their personal data to us in writing (with a wet signature or an electronic signature that substitutes for a wet signature), or through other methods determined by the Personal Data Protection Board, the request will be finalized by us in our capacity as data controller, depending on the nature of the request, as soon as possible and no later than thirty (30) days.





To ensure data security, we may request information from the applicant to verify whether the person making the application is the actual owner of the personal data subject to the application. Additionally, to ensure that the data subject's application is finalized appropriately, we may ask the data subject questions regarding their application.

If the data subject's application is likely to interfere with the rights and freedoms of others, requires disproportionate effort, or concerns publicly available information, the request may be rejected by us with justification.
